AGREEMENT TO PARTICIPATE AND RIGHT TO ENTER PROPERTY

General Program Guidelines:

- This program is limited to targeted areas of San Diego County and is subject to available funding.
- This is a voluntary program both the property owner and the RCD. If you volunteer for the RCD's "My Home Zone" Program, please be aware that logistical constraints, such as safety and accessibility issues, may prevent the RCD from being able to perform a comprehensive visual risk assessment of your property. This determination will be made upon the RCD's initial site inspection and you will be notified as soon as a determination has been made.
- Individual property consultations are limited to visual inspections for home fire safety and evacuation alternatives. The following items are included in the final Risk Assessment Report for your individual property:
 - Recommendations for alternative energy sources for emergency use
 - Recommendations for pet evacuation/relocation plans
 - Fire history, topographic, vegetation maps of the property and surrounding area (as available)
 - Aerial Photos of the property (as available)
 - Suggested improvements to provide a more defensible home and property include multiple home retrofitting improvements (such as replacing eave and roof vents), highly visible address signs, providing distance and protection of wood piles from structures, vegetation management and assessing for infestation of the Goldspotted Oak Borer (GSOB).
- The completed Risk Assessment Report is for informational purposes only.
- A follow-up visit will be arranged approximately 6 months after completion of the Risk Assessment Report.
- The RCD and its employees will not perform any physical installation or provide materials, equipment or supplies related to any recommended improvements to the property as part of this program.
- It is the strict policy of the RCD not to endorse or advertise specific products, vendors, equipment, etc.
- All personal information gathered during the course of this program is for the exclusive use by the RCD and its grantor(s) and will not be shared with outside entities.
- All participants must agree to the terms of the Program and provide a signed Right of Entry form to the RCD prior to the commencement of a property evaluation. Only original signed documents will be accepted.

1. Right to Enter and perform visual inspection of structures and property. Owner grants the Resource Conservation District of Greater San Diego County (RCD) and its employees, the right to enter their property to evaluate the existing condition of the structure(s) and land for potential life and property safety risks pertaining to fire.
2. No Cost to Owner. All education outreach and site assessments conducted under the "My Home Zone" program will be performed by the RCD no cost to the property owner.
3. Entire Agreement. The provisions of this written agreement shall constitute the entire agreement between Owner and the RCD and supersede any discussions, representations, understandings and prior agreements of any kind, oral and written, regarding the subject matter of this agreement.
4. Term of Agreement. This agreement shall be effective for one year.
